**Call to Order:** The meeting was called to order at 5:52 PM.

**Approval of Minutes:** None

**Treasurer's report** – Susan emailed her report. Gave details about the donation to the FA scholarship fund. 500 dollars was donated and split between each campus.

**Faculty rep to the board report** –

The **board met on Thursday, October 30** (later than normal due to ACCT Leadership Conference that several board members attended).

Items of interest:

- In Milford – renovations are being planned for Dunlap/Dining Hall
- In Lincoln – the next residential hall/dining hall is in the planning stages. Renderings coming soon – capacity of 248
- In Beatrice – The lineman program will begin in FA 26
- Voted to approve the revised Board Teams – which will include the newly created “Academic and Student Affairs” Team beginning January 2026
- TCA held their open house for their 10<sup>th</sup> anniversary on October 30
- Dr. Illich reported that many of the welding bays have sponsors which has raised approximately \$1 million.
- HLC conducted site visits at some of the high schools, correctional facilities, and learning centers on Oct. 30
- The HLC has created a “Micro-credentialing Lab” that SCC is interested in, but will not be part of the pilot group
- Amy Chesley presented information about Continuing Education – offerings, locations, enrollment, etc.
- Legislative update from Mueller/Robak; working on government relations between legislative sessions; 60-day session begins on January 7
- Names of candidates for District 4 open seat were voted on. The board moved 2 candidates on to the interview process on Nov. 4

I attended the **NCCA Conference** which was held in Lincoln on Nov. 2-3. At the Awards Ceremony Sunday night, **Trevor Nebesniak** was honored as SCC's recipient for the Faculty Member Award (congrats, Trevor!); **Bev Cummins** was awarded the Administrators/Staff Award; **Robert Ernesti** of Metalworks was honored as Distinguished Alumni; and **Arlyn Uhrmacher** was the NCCA overall Governors Award recipient.

The board also met on **Tuesday, November 4** to interview and appoint an individual to serve the remaining term of the vacant District Four seat on the board (Kristin Yates resigned from the board to accept a position with the college). **Matthew Haden** of Lincoln was selected from the interviewed candidates and will be sworn in at the board meeting on Nov. 18.

**Grievance Report:** Teresa Reporting. Have an instance regarding advising in the business division, and VP of instruction. A couple of meetings have taken place no resolution has been reached.

**President's report** – Met with an association member from arts and sciences. Had discussion about mandatory meetings and professional development. Reviewed the contract regarding the rules about attendance of mandatory meetings and proper scheduling. Teresa also sent out a survey regarding FSA accounts for health insurance. There have been several complaints as to the service that is being provided by the new vendor Omnify.
